In the event you require Emergency Service to your vehicle's engine, transmission, final drive (differential), or front suspension and a GMC Motorhome Service Representative is not located in the immediate geographic area — the nearest Oldsmobile dealer may be able to offer you emergency service assistance. Any work performed will be at the discretion of the particular Oldsmobile dealer contacted. You will be required to pay the servicing Oldsmobile dealer and if the vehicle is under Warranty, the repair order can be submitted to the selling GMC Motorhome Service Representative for review and consideration for reimbursement.

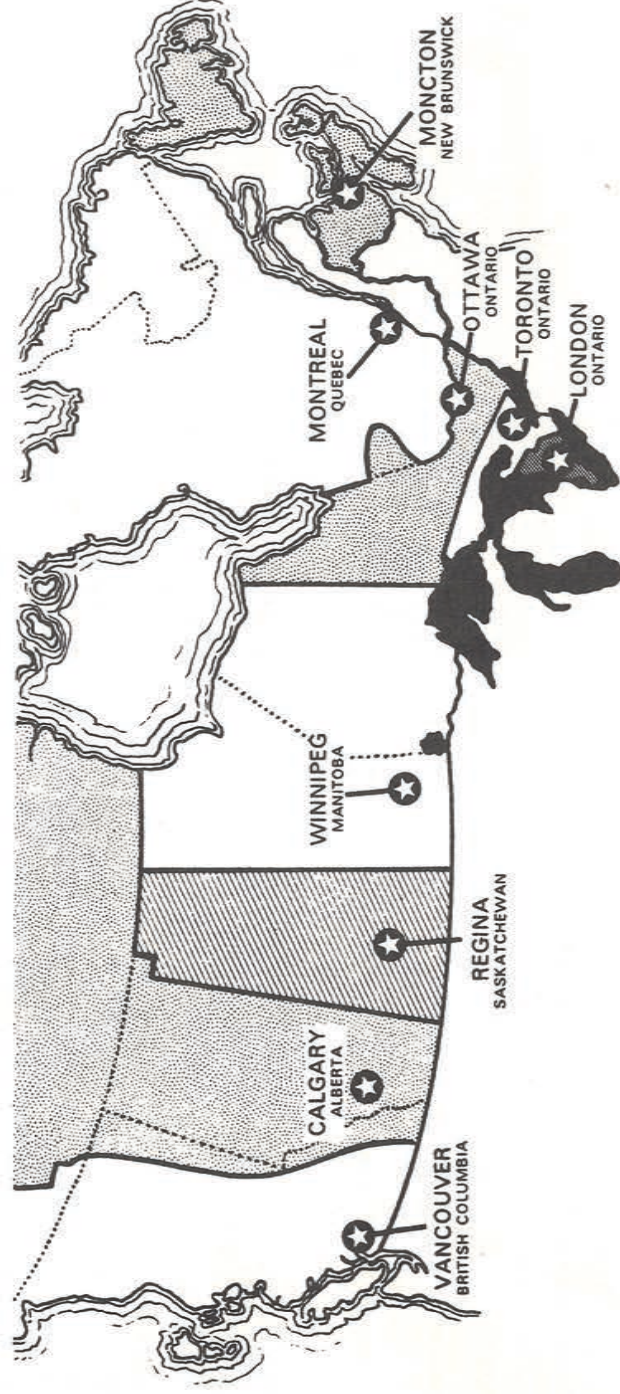
